**GLOBAL EXPRESSION OF INTEREST (EOI) FOR PROVISION OF
SINGLE POINT MOORING (SPM) SUPPORT VESSEL IN BHOGAT, GUJARAT**

Cairn Energy India Pty Ltd. ("CEIL") is the Operator on behalf of Joint Venture partners CEHL, Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation, of the Contract Area RJ-ON-90/1 at Barmer in the state of Rajasthan, India. The RJ-ON-90/1 Block contains a number of major oil discoveries, including the Mangala field, the largest onshore oil discovery in India since 1985. CEIL and its JV partners have approval from Government of India (GOI) for a pipeline to transport crude oil from the Block at Barmer, Rajasthan to a coastal terminal facility in Gujarat.

The scope of work for this EOI is limited to provision of Single Point Mooring (SPM) support vessel in Bhogat ,Gujarat India on a one (1) year charter hire basis. The work scope would consist of the following:

The Vessel shall be mobilized to and demobilized from the SPM location at Bhogat, Gujarat ,India. The SPM is located at the following co-ordinates in depth of approximately 30 m.

Co ordinates of LFP: 21 deg 58.4 min N, 069 deg 12.3 min E.

Co ordinates of SPM: 21 deg 56.0 min N. 069 deg 9.9 min E.

There is no landing place at Bhogat. All tasks including supply of fresh water, fuel and stores and crew change would required to be done at Okha or Porbandar or near SPM location in consent with Charterer and under compliance with the authorities requirements.

CEIL on behalf of its joint venture partners invites reputed Contractors (Indian and international both) with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in international competitive bidding process ("ICB"). In view of the nature of the scope, only those Companies possessing the requisite and proven record of performance in executing at least Two (2) similar job of value exceeding Indian Rupees 1.5 Crores in last 3 years should respond to this notice.

In addition to the above requested documentation, bidders shall also submit credentials to support the specific qualification criteria for each package.

Companies are requested, as a minimum, to submit the following documents and details for prequalification:

1. Health safety Environment system (HSE)
 - a) HSE policy and Manual.
 - b) HSE statistics for major projects executed in last 3 years.
2. Letter of Interest with detailed company information:
 - a) State the name of the parent company.
 - b) State the name/address/phone/e-mail of the company that would execute the contract.
 - c) If a joint venture to be proposed, state the name/address/phone/email of all joint venture partners.
 - d) Organization structure.
 - e) Size of the departments.
3. Company's financial performance documents(Including JV Partner's financial , if proposed) i.e. **Audited** balance sheets, Profit and Loss Account & cash flow statement for last 3 years & following details separately.

- a. SPM support vessel shall be steel hull vessel and classed with a society which is member of International Association of Classification Societies (IACS) and must be carrying all the statutory certificates as described by her Flag administration.
 - b. Vessel shall comply with all applicable National, International and local rules and regulations.
 - c. Zodiac boat with 25 HP OBM (Outboard motor) for SPM related operation.
 - d. Certified tools and tackles for carrying out topside maintenance as described by CEIL.
 - e. SPM Support Vessel's basic Specifications/requirements:
 - ❖ Main engine BHP 500 minimum.
 - ❖ Deck winch of minimum 2 ton capacity.
 - ❖ Clear deck space approx 30 sq m.
 - ❖ Two working anchors.
 - ❖ Adequate Bunker, Fresh water capacity and provisions capacity for minimum 15 days endurance.
 - ❖ VHF, RT, DSC, NAVTEX, GPS, echo sounder, Radar, handheld anemometer, Searchlight capable of rotating 360 degrees and operable from wheel house and any other statutory navigational equipment.
 - ❖ Contractor must have adequate insurance coverage against meeting the all costs from an Insurer with coverage relating to wreck removal, oil pollution, and damage to fixed/floating platforms or vessels. The coverage under this insurance shall not be less than the liability as prescribed in chapter – X of M.S. act, 1958.
 - ❖ Contractor to comply with Director General of shipping requirements regarding Special period license, General trading license and specified voyage license.
 - ❖ Contractor to comply with Director General of Shipping Mumbai Shipping Development circular regarding chartering of Vessels under section 406 and 407 of Merchant shipping act 1958.
 - ❖ Delivery: Bhogat/Gujarat/India 1st week May 2011
 - f. Discipline and geographical location wise company's fleet strength for providing similar type of services.
 - g. Details of fleet owned by the company.
6. Quality Systems.
- a) Copy of International Safety Management certificate (Document of Compliance and Ship management system as applicable.)
 - b) Certification of the company's QA system by an accredited certification body.
 - c) Quality Environment Management System of the company.
 - d) Copy of registration certificate (Labour Law, EPF etc. as applicable)
