Cairn Energy India Pty Ltd. ("CEIL") is the Operator, on behalf of Joint Venture Partners, CEIL and ONGC, of the RJ-ON-90/1 Contract Area in the State of Rajasthan, India. Subsequent to a successful oil discovery in the area, CEIL is in the process of developing the Northern Area Fields. CEIL shall require three (3) Mobile Fire Fighting Multipurpose (FOAM and DCP) Fire Tender units, built on 4X 4 MAN CLA 16.180 or Volvo FM 340 6x4 rigid diesel Engine or equivalent chassis suiting to detailed specifications and one (1) Foam Nurser Unit and Hydraulic rescue tools as per details given in the detailed tender document to be issued to pre qualified vendors.

CEIL seeks expression of interest (EOI) from suitably experienced Fire Tender manufacturers to build and supply the Fire tenders and to complete the work which broadly encompasses the following:

- Centrifugal type fire pumps of 4000 lpm discharge capacity at 7.0 kg/cm² (g) and 300 lpm at 35 kg/cm²
- Diesel engine and chassis
- Power takes of unit (P.T.O.) for driving the pump
- Auxiliary foam connection
- Water tank of 3000 Ltr. capacity (Stainless steel)
- Foam tank of 3000 Ltr. capacity (Stainless steel)
- Water foam monitor mounted at the top
- One DCP monitor
- Two High pressure hose reels
- Battery operated amplifier system
- One DCP vessel of 750 kg capacity charged with 750 Kg of Monnex powder
- One DCP monitor
- One Hose Reel 35 mm nominal bore and 30 meter length for DCP
- Expellant gas system having nitrogen gas in cylinders with spare cylinder
- Piping, necessary controls, hose lines and other accessories etc. complete
- One Foam Nurser of 7000 litres capacity
- Rescue tools

With this EOI, CEIL intends to short list names of experienced manufacturers of fire tender Equipments for Invitation to Bid for the same.

Each Bidder shall necessarily be a Fire Tender Manufacturer, shall have proven manufacturing experience of more than five (05) years in similar types of Mobile Fire fighting equipments, and shall have sufficient and experienced crew, equipment, management and organisational processes to provide the desired level of services. The Bidder shall be able to demonstrate full understanding of internationally accepted Health, Safety and Environmental practices, procedures and policies. Only Bidders who can comply with these requirements and can demonstrate a successful track record, listing projects, clients and client contacts who may be approached, should respond to this notice.

Bidders are requested, as a minimum, to submit the following documents and details:

1. Lists of similar work successfully executed in the last three years and projects currently under execution.
2. One single work order of Similar nature successfully executed in last five (5) years
3. Crew details including bio-data of key personnel.
4. Fleet availability details with the latest audit certifications and reports.
5. The most recent organisational audit report
6. Lists of policies, procedures and quality assurance practices currently in place for the execution of similar work.
7. Health, Safety and Environment policies, procedures and statistics covering the last four (4) years
8. Corporate financial details
