



## GLOBAL "EXPRESSION OF INTEREST" (EOI) FOR WATER TREATMENT PLANT FOR RAJASTHAN BLOCK

Cairn Oil and Gas, a vertical of Vedanta Limited is the Operator of the Onshore **RJ-ON-90/1** block (located in Barmer District of Rajasthan, India), on behalf of itself and its Joint Venture (JV) partners.

Operator intends to install readily available Water Treatment plant of **40,000-60,000 bpd** treated water capacity on rental/purchase/buyback basis (along with all ancillary utilities, static and rotating equipment's, etc.). The contractor shall provide the performance guarantee of the units and meet required treated water specification at outlet. The Contractor shall also be carrying out Operation & Maintenance for the supplied package for the entire duration of Contract in case of rental & buyback option."

## (Go/No Go) Criteria for Pre-Qualification:

## Technical (Go/No Go)

- Interested party shall have experience in supply or rental services for Water Treatment Plant of minimum 15,000 bpd unit capacity in the last 5 years
- 2. Past experience of minimum 1 year in water treatment
- 3. Delivery Timelines of Water Treatment Plant shall be within **20 weeks** post award

## Financial (Go/No Go)

- 1. Positive net worth in the immediately preceding two financial years.
- 2. Turnover in each of the preceding 2 financial years should be equal to or more than the estimated average annual contract value.
- 3. Liquidity ratio of bidders in each of the preceding two financial year shall not be less than 1

Companies are requested, as a minimum, to submit the following documents and details

- 1. Letter of interest to participate in the EOI [Expression of Interest] clearly indicating the EOI reference along with company information detailing their nominated management, staff, and business process support.
- 2. Documents in support of financial capabilities: Company's financial performance documents (Audited Balance sheets and Profit and Loss statements, Auditors Report and Notes to Accounts etc.) for last 2 (two) years. Latest financial statement should not be older than 12 months on the date of submission of response to Expression of interest.
- 3. Documents in support of supply/rental capabilities: Companies are requested to submit details of their capabilities indicating
  - a. Overall supply/rental capability details including product catalog along with different capacities.
  - b. Details of similar Water Treatment plant supplied in last 5 years.
  - c. Experience certificate/PO copies indicating no of years of experience for supply/rental for water treatment plant with O&M services
  - d. List of current ongoing/completed contracts of similar nature under execution.
  - e. Supply experience for Hydrocarbon Sector indicating details as listed below:
    - i. Brief scope of work including quantity supplied & year of supply,
    - ii. Value of Supply
    - iii. Tenure of contract
    - iv. Client name,
    - v. Completion Certificate
    - vi. Contact details of client [OPERATOR may approach the client directly for feedback]
    - vii. Customer feedback on supply
- 4. HSE (Health, Safety, Environment) policy and implementation procedures in line with internationally accepted practices 5. Quality assurance & Quality control practices currently in place for the execution of similar requirement
