

EXPRESSION OF INTEREST (EOI) FOR THE RIG MOVE SERVICES FOR RJ-ON 90/1 BLOCK

Introduction

The Company seeks an expression of interest under competitive bidding procedures from suitably experienced Transport Contractors to provide Rig Move Services

Services required

The scope of work for this EOI comprises of Drilling Rig Movements from one location to other.

Contractors who have a minimum of 5 years' experience in carrying out such services and have proven record of performance in executing similar jobs will be considered.

Specifics

Only those Contractors who can comply with all of the following and can, by their submission, demonstrate a successful track record, listing previous projects, current Services projects in progress, clients, and client key contacts who may be approached, in each of the areas below should respond to this Notice. The Contractor must submit details for the following:

- Organizational structure, detailing their nominated management, staff and business process support to carry out the Services.
- Details of completion of similar type of jobs in the last five years
- Single largest value of Contract executed in the last five years
- Details of fleet viz. trailers, cranes, trucks, etc. owned by Contractor. Preference will be given to company who owns material handling fleet.
- A demonstrable capability to commence work to meet the schedule of CIL. The Contractor's experience in completing the work on schedule shall be clearly stated.
- Have an appropriate and comprehensive Health, Safety and Environmental management system
 in place which promotes, aligns with and upholds the commitments of CIL and the Contractor.
 Details of their certification shall be submitted.
- Willingness to develop a close long term relationship with CIL
- Sound HSE policy in place.



- Quality assurance & Quality control practices currently in place for the execution of similar work
- Audited financial statements for the last three years
- Contractor must demonstrate that they have sufficient financial standing to commence and continue an operation of this magnitude
