Cairn Energy India Pty Ltd. ("CEIL") is the Operator of the Offshore Ravva block located in the east coast of India. CEIL is planning to engage an experienced Contractor for Procurement, Fabrication, Erection and Commissioning Services for Electrical & Instrumentation System, Civil Construction & Structural works as part of up-gradation of WISU-II (Water Injection System Up-gradation) Project.

CEIL seeks Expression of Interests from suitably experienced Contractors who wish to receive tender documents for the above services under Competitive Bidding procedure.

A) Details of the Services

CEIL is planning to upgrade the water injection capacity by installing a motor driven high pressure pump (bought out item) and gas compression capacity by retrofit of existing compressor. As part of these two projects, installation of high pressure pump skid, HT VFD panel & modification of electrical system, interfacing with existing plant by plant piping (mainly 10" to 14") work of approximately 1Km along with installation of civil works for pipe supports, instrumentation required for process control, erection/installation of equipment and commissioning assistance needs to be taken up. These works are expected to start during first Week of Sept'2010 and to be completed by second Week of Feb'2011
