## GLOBAL EXPRESSION OF INTEREST / PRE-QUALIFICATION FOR "BATHYMETRY SURVEY FOR KG-OSN-2009/3 BLOCK IN SHALLOW WATER KG BASIN, INDIA - PREQUALIFICATION 2010"

## **Introduction**

Cairn Energy India Pty Ltd. ("CEIL") is the Operator of the Offshore Block KG-OSN-2009/3 Contract Area. The Contract Area lies in the East Coast of India in Shallow Water in KG Basin. As part of the initial exploration phase for this Contract Area CEIL wish to acquire Bathymetry Survey in approximately 2000sq km area and current measurement (modelling). It is envisaged that the work will be conducted in Q4 2010/Q1 2011.

CEIL seeks expression of interest (EOI) from suitably experienced bathymetry data acquisition and current measurement (modelling) contractors for the work which broadly encompasses the following:

- Shallow water Bathymetry Survey 5m to 60 meters
- Current Measurement data from 2 to 5 locations will be used for modelling
- Logistics support for the offshore operation including provision of support vessel if required.
- Provision of processing for quality control of acquired bathymetry data.

With this EOI, CEIL intends to short list names of experienced Contractors to invite for the tender for the Bathymetry Survey and Current Measurement (modelling). Interested party may submit there expression either for bathymetry survey and current measurement or any of them.

The company shall have proven experience in similar types of operations, and shall have sufficient personnel, equipment, management and organizational processes to conduct the works. The company shall be able to demonstrate full understanding of Indian and internationally accepted Health, Safety and Environmental practices, procedures and policies. Only companies who can comply with these requirements and who can demonstrate a successful track record, listing projects, clients and client contacts that may be approached, should respond to this notice.
