# GLOBAL EXPRESSION OF INTEREST (EoI) FOR THIRD PARTY INSPECTION, VERIFICATION AND CERTIFICATION SERVICES FOR BHAGYAM AND AISHWARIYA FIELD DEVELOPMENT AND MPT CAPACITY EXPANSION PROJECT

Cairn Energy India Pty Ltd. ("CEIL") is the Operator on behalf of Joint Venture partners CEIL, Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation, of the Contract Area RJ-ON-90/1 at Barmer in the state of Rajasthan, India. The RJ-ON-90/1 block contains a number of major oil discoveries namely Mangala, Bhagyam, Aishwariya and other fields. The Mangala field is the largest onshore oil discovery in India since 1985. The Mangala field development consists of well pad facilities and processing hub named Mangala Processing Terminal (MPT) which is currently under implementation.

As next phase of development it is now proposed to develop Bhagyam and Aishwariya Satellite fields and capacity expansion of current MPT (consisting of well pads, infield and trunk pipeline, OHL and other infrastructure facilities and addition of new processing equipment). The development activity has already commenced.

CEIL on behalf of its joint venture partners' seeks Expression of Interest under International Competitive Bidding Process ("ICB") from suitably experienced Agencies (Indian and International both) for the above mentioned services. Only those Contractors possessing the requisite and proven record of performance in executing similar jobs of this magnitude in operational Oil & Gas / Refinery plants should respond to this notice

### Specific Qualification Criteria:-

- Executed at least two (2) similar jobs of value USD 1 million.
- Average annual turnover for last two (2) years should be US\$ 2 Million or more.

#### **Brief Scope of Work**

The scope of services includes multi-disciplinary Third-Party Inspection, verification and certification activities during different stages of Engineering, Procurement and Construction phases of the project. As a minimum, these activities comprise the inspection /verification for Compliance to ITPs for Stage-wise and final stages of Inspection followed by certification at shop and site during fabrication / manufacturing / FAT / receipt inspection / construction activities / Installation & laying / erection / SAT / support during pre-commissioning and commissioning.

  - Operation strategy.
  - Monitoring and control mechanisms.
  - Details of Softwares used for design verification / validation.
  - Details of technical Collaboration, if any.
- 4. Company's financial performance documents i.e. Audited Balance Sheets, Profit and Loss Account & Cash Flow Statement for the last 3 years & following details separately:
  - Company Turnover based on last 3 audited/Financial statement
  - Company's Net Worth based on last 3 audited/Financial statement

  - Working Capital based on last 3 audited/Financial statement
  - State the banker's name, address and Solvency certificate from the bank indicating the credibility limit in financial terms.
