EXPRESSION OF INTEREST (EOI) FOR SUPPLY OF PROCESS EQUIPMENT FOR RAJASTHAN DEVELOPMENT PROJECT

Cairn Energy India Pty Ltd. ("CEIL") is the Operator, on behalf of the Joint Venture Partners, CEIL, Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation of the RJON-90/1 Contract Area in the state of Rajasthan, India. The RJ-ON-90/1 Block contains a number of major oil discoveries, including the Mangala field, the largest onshore oil discovery in India since 1985. The field development activities for Mangala field have commenced with the awarding of civil and construction contracts. CEIL and their Joint Venture Partners have obtained the approval from Government of India (GoI) to proceed with the development of the Bhagyam and Aishwariya fields.

CEIL intends to set up hydrocarbon production / injection facilities in the RJ-ON-90/1 Block, consisting of major process equipment packages as outlined below, subject to obtaining the relevant approvals :

- 1. Alkali-Surfactant-Polymer Injection facilities for chemical based EOR
- 2. Medium Pressure Three Phase Separators 2 nos.
- 3. Low Pressure Three Phase Separators with Electrostatic Coalescers 2 nos.
- 4. Sand Separator 1 no.
- 5. Fuel Gas Conditioning Skid
- 6. Fired Heater packages (5 10 MMKCal/hr for Hot water / Thermic fluid) 5 nos.
- 7. Shell & Tube Heat Exchangers (2 12 MMKCal/hr) 5 nos.
- 8. Diesel Engine driven Pump Skids 4 nos.
- 9. Piping and Valves
