EXPRESSION OF INTEREST (EOI) FOR THE PROVISION OF PERSONAL PROTECTIVE EQUIPMENT FOR CAIRN LANKA (PVT) LTD , SRI LANKA OPERATIONS

Cairn Lanka Private Ltd. ("CLPL") is the Operator of the Offshore **SL-2007-01-001** Contract Area. The Contract Area lies in the Gulf Mannar in deep water, just off the NW coast of Sri Lanka. CLPL is planning to commence exploration drilling activities (3 firm wells + 2 optional wells) in the SL-2007-01-001 by August 2011.

For its staff movement in SriLanka, CLPL shall require assorted PPE and specific safety equipment confirming to International Association of Oil & Gas Producers (IAOGP) guidelines for their base office in Colombo.

The equipment is required and to be supplied on a replacement basis for a period of 06 months with effect from 15th August, 2011 to 14th February, 2012. (The renewal on monthly basis can be done thereafter as per requirement)

CLPL seeks expression of interest (EOI) from suitably experienced PPE and Safety Equipment contractors for the work which broadly encompasses the following:

1. PPE Clothing and Equipment required :

- (i) This Personal Protective Equipment Plan applies to all staff working on the Campaign and addresses full body, eye, face, head, foot and hand protection.
- (ii) Personal protective equipment (PPE) includes all types of equipment used to increase individual safety while performing potentially hazardous tasks. This may include safety glasses, hard hats, gloves, lab coats, respirators, or any equipment used to protect against injury or illness.
- (iii) Specific item quantities will be detailed during the procurement process.

2. Scope of Work & Application

The Standards imposed requires PPE to be provided, used, and maintained in a sanitary and reliable condition wherever hazards of processes or environment, chemical hazards, radiological hazards, or mechanical irritants are encountered in a manner capable of causing injury or illness through absorption, inhalation, or physical contact. Departments are responsible for ensuring the adequacy of the equipment and ensuring that it is properly maintained, even in those cases where employees provide their own PPE.

3. Selection of PPE:

Hazard Assessment

Hazard assessment procedures shall be used to assess the workplace to determine if hazards are present, or are likely to be present, which necessitate the use of personal protective equipment (PPE).

Controlling Hazards

PPE devices alone should not be relied on to provide protection against hazards, but should be used in conjunction with guards, engineering controls, and good hygiene practices.

Selection Guidelines

In order to select protective equipment that is appropriate for the task one must become familiar with the potential work hazards and the type of protective equipment that is available. All personal protective equipment shall be of safe design and construction for the work to be performed and must meet relevant ANSI Standards as applicable.

Fitting the PPE

Careful consideration must be given to comfort and fit. PPE that fits poorly will not afford the necessary protection. Continued wearing of the device is more likely if it fits the wearer comfortably. Protective devices are generally available in a variety of sizes. Care must be taken to ensure that the right size is selected.

Devices with Adjustable Features

Adjustments should be made on an individual basis for a comfortable fit that will maintain the protective device in the proper position. Particular care should be taken in fitting devices for eye protection against dust and chemical splash to ensure that the devices are sealed to the face. In addition, proper fitting of helmets is important to ensure that it will not fall off during work operations. In some cases a chinstrap may be necessary to keep the helmet on an employee's head. (Chinstraps should break at a reasonably low force, however, so as to prevent a strangulation hazard.) Where manufacturer's instructions are available, they should be followed carefully.

Eye and Face Protection

Each affected employee shall use appropriate eye or face protection when exposed to eye or face hazards from flying particles, molten metal, liquid chemicals, acids or caustic liquids, chemical gases or vapors, or potentially injurious light radiation. Each affected employee shall use eye protection that provides side protection when there is a hazard from flying objects. Detachable side protectors are **NOT** acceptable and must not be utilized.

Eye and face PPE shall be distinctly marked to facilitate identification of the manufacturer. Each affected employee shall use equipment with filter lenses that have a shade number appropriate for the work being performed for protection from injurious light radiation. A listing of appropriate shade numbers for various operations follows.

4. Compliance

- (i) All requirements for compliance of road safety are as given in the Cairn Personal Protective Policy Guidance, which will be available upon request.
- (ii) Cairn Lanka HSE Project Plan
- (iii) All Contractors who wish bid should comply with Sri Lankan government requirements stipulated under the BOI and its amendments to import and supply.
- (iv) All contractors should conform with the OGP Standards and protocols.

With this CLPL intends to short list names of experienced contractors for invitation to bid for the same.

Interested Contractors who can fulfil all the criteria listed above shall submit their response with the following details within 10 days of publication of this advertisement to the address given below:

- 1. Company profile, Organization, Set-up
- 2. List of suppliers and manufacturers and providers
- 3. List of similar work successfully executed in last 2 years and contract in hand

4. Balance Sheet and P/L account for last 2 years
