EXPRESSION OF INTEREST (EoI) FOR HIRING OF LIFTING EQUIPMENTS

Cairn India Ltd (“CIL”) is the Operator of the Onshore **RJ-ON-90/1** block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

The scope of work/ services would broadly consist of the following:

To meet the resource requirement CIL intend to award contract for hiring of lifting equipments for 3 years at MPT, Well pads & Aishwarya to interested competent party. The brief scope of work of the contractor under this contract is to establish contract for hiring of lifting equipments for 3 years as per the requirement of CIL at MPT, Well pads & Aishwarya.

The hiring of lifting equipments is required continuously for a period of Three years from the date of Award of the contract and can be renewed on the existing terms and conditions including rates for a period of One Year in Two slots of Six month each.

Work Overview:

Contractor shall provide lifting equipments for the Mechanical Department and Operations Support at Company’s MPT, well pads and Aishwarya Facilities in Barmer, Rajasthan. The Contractor shall supply suitable lifting equipments as per the desired specifications to provide assistance for Three year from the date of placing the contract.

Contractor shall supply the diesel operated forklift, mobile hydra, cheery picker, Telescopic crane, Hydra mobile crane, truck mounted man lift 80 ft. etc for lifting of materials to support company's operations sites at MPT & well pads and Aishwarya site in Barmer, Rajasthan.

The following parameters are to be considered while responding to the EOI

COMMERCIAL :-

1. Net worth of the company shall be at least INR 60 lakhs in preceding two financial years.
2. The average annual turnover of the company shall be INR 6.05 Cr. or more for the last 02 financial years.
3. Liquidity ratio shall not be less than 0.75 in the past 02 years.
4. Company's financial performance documents (Audited balance sheets and Profit & Loss statements etc) for last 3 years.
5. The contractor should have executed / supplied similar kind of lifting equipments for Oil & Gas Companies with client completion certificates.

TECHNICAL :

- a) Experience
 - (1) Vendor must provide reference of similar Lifting & transport vehicles supplied in Oil & Gas / Refinery Companies with client completion certificates.
 - (2) Company organization structure with Total Strength
 - (3) HSE track record.
 - (4) Details of current commitments
- b) Quality Systems:
 - (1) Copy of current ISO Certificate provided
 - (2) Certification of the companies QA system by an accredited certification body

CIL on behalf of the JV partners invites reputed contractors with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in Competitive Bidding Process. In view of the nature of the scope, only those Companies complying the requirements and proven record of performance should respond to the EOI.

Further to this, interested suppliers would be invited to submit their response via *Smart Source* (Cairn's e Sourcing Platform). In addition to the above requested documentation, bidders shall also submit credentials to support the specific qualification criteria.

Companies are requested, as a minimum, to submit the following documents and details for pre-qualification:

1. Letter of interest
2. Detail Company Information with Organisation structure,
3. Experience of supplying similar lifting equipments in similar type of industries of at least 3 years.
4. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years.

5. ISO-9001 certification to company.
