EXPRESSION OF INTEREST (Eoi) FOR PROVISION OF ELECTRICAL O & M MANPOWER FOR RAJASTHAN BLOCK

Cairn India Ltd ("CIL") is the Operator of the Onshore **RJ-ON-90/1** block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

The scope of work/ services would broadly consist of the following:

To meet the resource requirement CIL intend to award contract for Electrical O & M Manpower to interested competent party. The brief scope of work of the contractor under this contract is to carry out Electrical O & M works as per the requirement of CIL for MPT & Well pads.

The Electrical O & M services required continuously for a period of Three years from the date of Award of the contract and can be renewed on the existing terms and conditions including rates for a period of One Year in Two slots of Six month each.

Services included but not limited to the following::

- The contractor shall carry out the preventive, routine and breakdown maintenance all the lighting fixtures and its associated switchgear like lighting transformer, Lighting switchgear, LDB, wiring and lighting cable laying etc. inside and outside the plant and building area as required by CIL electrical In-charge.
- The contractor manpower doing the lighting maintenance shall have at-least Seven years of experience in doing the maintenance and should possess trouble shooting skills in all kind of light fittings.
- The contractor manpower shall be responsible for carrying out temporary lighting and power supply connection and disconnection as & when required.
- The Contractor manpower shall be responsible for carrying out earth pit maintenance.
- The contractor manpower shall carry out panel wiring and termination. The Personnel shall be skilled enough to do such wiring inside the panel.
- The contractor supervisor is responsible for maintaining lighting spares inventory at sub stores and shall be responsible for issue of such spares.
- The lighting fixture and component spares for maintenance shall be supplied by CIL.

CIL on behalf of the JV partners invites reputed Contractors with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in Competitive Bidding Process. In view of the nature of the scope, only those Companies meeting the following criteria as a minimum should respond to the EOI:

- The contractor should have executed similar kind of services for Oil & Gas plants for a minimum of 7 years.

- The average annual turnover of the company in the last 3 years shall be INR 3 Crores.
 - Organizational strength, Availability of adequate manpower of requisite qualification.
 - The net worth of the company should be positive.

Further to this, interested suppliers would be invited to submit their response via *Smart Source* (Cairn’s e Sourcing Platform). The suppliers would be requested, as a minimum, to submit the following documents and details for prequalification via *Smart Source*

In addition to the above requested documentation, bidders shall also submit credentials to support the specific qualification criteria for the package.

Companies are requested, as a minimum, to submit the following documents and details:

1. Detail Company information with Organization structure, List of manpower with CV’s of key personnel, Parent company, Plant & machinery list mentioning year of manufacture, support agencies and other facilities and resources.
2. List/ Details of similar type of projects successfully executed in the last three years and similar projects/agreements currently under execution under headings a) Brief scope of work b) Value of work c) Contractual duration d) Actual completion of project e) Client name f) Contact details of client (CIL may approach the client directly for feedback)
3. Typical project planning and execution methodology
4. Details of capability to mobilise and commence work to meet CIL’s schedule. The Contractor’s experience in mobilising on schedule should be clearly stated.
5. Details of Particular experience of providing Services in remote areas where rapid mobility and flexibility to accommodate CIL’s programme is paramount. Evidence supporting successful major operations in remote areas must be submitted.
6. List of policies, procedures and quality assurance practices currently in place for the execution of similar work.
7. Health, Safety and Environment (HSE) policies, procedures, manual in line with internationally accepted practices and HSE statistics covering the last 3 years
8. Quality assurance & Quality control plan/ procedures in place for the execution of similar type of work, Copy of ISO or any other certification as applicable.
9. Copy of registration certificates (Labour law, EPF, Registration etc)
10. Business presence in the region

The interested suppliers should evince interest to participate in EOI within 14 days of publication of Expression of Interest.
