EXPRESSION OF INTEREST FOR PROVISION OF HELICOPTER SUPPORT SERVICES

SCOPE OF SERVICES

The Scope of Service will include but not be limited to the provision of technical support, equipment and personnel as necessary for provision of helicopter support services, including passenger and freight handling for transportation of:

- a) Company's personnel and others as may be directed by the Company; and
- b) Freight, which is the property of Company and others, to be carried internally or externally, under slung

Helicopters should have CAT-3 capabilities, twin engine, twin pilot, IFR instrumentation & VFT capabilities, 9+2 pax, sufficient space for cargo handling, SAR capable with winch and having under slung capabilities.

Contract Period: Firm two years with one year extension option.

CEIL on behalf of its joint venture partners invites reputed contractors having a minimum of 5 years relevant experience in an offshore environment with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in competitive bidding process.

8. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 5 years.
9. Accident/Incident statistics for past 5 years.
10. Details of engineering/maintenance facilities within India with valid certificate of approval by Director of Air worthiness.
