Cairn Energy India Pty Ltd (CEIL), as an operator on behalf of joint venture partners Cairn India & ONGC in contract area RJ-ON-90/1 in the state of Rajasthan, India is carrying out drilling in the block RJ-ON-90/1. Drilling activity is scheduled to commence in Q2/2012.

As an environmentally responsible concern, CEIL, intends using a Vertical Cuttings Dryer Package in the company's onshore drilling operations in Rajasthan to reduce drilled cuttings and fluids waste disposal and recover drilling fluids for re-use.

Proposed package design will have provision to include a belt-driven Decanting Centrifuge as part of the VCD package.

The company shall have proven experience in similar supplies, and shall have sufficient personnel, equipment, management and organisational processes to conduct the works. The company shall be able to demonstrate full understanding of working in remote and environmentally sensitive areas such as Rajasthan and of internationally accepted Health, Safety and Environmental practices, procedures and policies.
