

## **EXPRESSION OF INTEREST (EoI) FOR VARIOUS CIVIL WORKS IN RAJASTHAN BLOCK ON NATIONAL COMPETITIVE BIDDING (NCB) BASIS**

Cairn India Limited now Merged with Vedanta Ltd is the Operator on behalf of itself and Joint Venture (JV) partner Oil & Natural Gas Corporation (ONGC) Ltd., of the onshore block RJ-ON-90/1 (the “Block”) located in Barmer and Jalore district, in the state of Rajasthan, India. The Block contains a number of major oil discoveries including the Mangala, Bhagyam, Aishwariya, Raageshwari and other fields.

Operator on behalf of itself and its joint venture partners invites Expression of Interest for below Projects under National Competitive Bidding (“NCB”) process from reputed Civil/ Construction bidders with requisite experience of said Civil works with demonstrated HSE Performance.

**Scope of Work:** The broad scope of work/ services under this EoI consists of

**Package # 1:** Miscellaneous Civil works - related to development or repair/ restoration works for Drill sites, Camp sites, existing well pads, new well pads, Terminal areas. It predominantly comprises of Site grading, Fencing, access roads, Precast Boundary wall, RCC Cellar pits, Equipment foundations, Pipe supports, Waste pits, Fresh water Pits, Flare pits, Slope protection works, Buildings etc involving earth works, Concrete, Rebar, Structural steel, masonry, bituminous roads, Pre-casting, building finishing, furnishing & architectural works and associated civil works.

**Package # 2:** Gabion wall works - Construction of Gabion wall involving earth works, Supply & Installation of Cage, Geotextiles, Stone works and associated Civil works

The said activities are to be executed in different phases spread over next two to three years.

Only those parties who meet following criteria shall be considered.

### **Package # 1 –**

**Technical:** Companies possessing the requisite and proven record of successful execution civil works in last 10 years. Bidder to have experience in Oil & Gas / Refinery / Petrochemical Plants is mandatory.

### **Financial:**

1. Bidder annual average Turnover in immediately preceding two financial years should be at least INR 14 crores.
2. Bidder should have Positive Net worth of INR 14 Crores as minimum in each of the immediately preceding two financial years.
3. Liquidity ratio of bidders in each of the preceding two financial years shall not be less than 0.6

## Package # 2 –

**Technical:** Contractors should have executed similar Gabion works/ major masonry/ Concrete retaining wall structures/ Wing walls/ RR masonry rip rap/ Stone pitching works in last 10 years.

### **Financial:**

1. Bidder annual average Turnover in immediately preceding two financial years should be at least INR 20 crores.
2. Bidder should have Positive Net worth of INR 20 Crores as minimum in each of the immediately preceding two financial years.
3. Liquidity ratio of bidders in each of the preceding two financial years shall not be less than 0.6

Bidders are requested to submit the following documents as a minimum

- ❖ Letter of interest with detailed company information & Package(s)
- ❖ Past Track record of similar works executed list with Work order, P.O Copies or LOI copies and Client completion certificates.
- ❖ Detailed Company Information with Organisation structure, List of manpower with details of key personnel (Project Manager/ Maintenance Manager /Head of Operations) and other facilities and resources.
- ❖ Details of current commitments
- ❖ Details of completion of similar type of contracts in the last five years and similar contracts/agreements currently under execution under headings:
  - Brief scope of work
  - Value of work in INR
  - Contractual Duration
  - Actual completion of Project
  - Clients name
  - Contact details of the Client. ,
- ❖ Company registration details, PF, ESI, Pan Card, Service tax CST / VAT, details.
- ❖ Details of Particular experience of providing Services in remote areas. Evidence supporting successful major operations in remote areas must be submitted.
- ❖ Bidders are requested to submit Company's financial performance documents
- ❖ Details of Particular experience of providing Services in Green field/ Brown field Oil & Gas working locations. Evidence supporting successful execution in Oil & Gas must be submitted.
- ❖ Documents in support of Health, Safety, Environment & Quality [HSEQ] performance
- ❖ HSE statistics covering the last 3 years,
- ❖ Quality assurance & Quality control plan/ procedures in place for the execution of similar type of work,
- ❖ Copies of ISO 9001, 14001, OHSAS 18001 or any other certification as applicable.

EOI submission shall be complete with the above requested information.
