- 6. Details of Management, Operating and Maintenance schemes with copies of certification.
- 7. List of policies, procedures and quality assurance practices currently in place for the execution of similar work.
- 8. HSE policies, implementation procedures in line with accepted practices.
- 9. Copies of ISO certifications.
- 10. In case of sub-contracting, submission of above relevant documents of the proposed subcontractors.
- 11. Contractor should have executed similar at least one project of value \$ 0.38 MM in last three years.
- 12. Average annual turnover of the Contractor shall not be less than \$ 0.77 MM in last three years.
- 13. Company's financial performance documents i.e. audited balance sheets, profit and loss account etc. for last 03 years
