Global Expression of Interest (EOI) under International Competitive Bidding For Installation of Reject Water Pipeline System For Rajasthan Block

1.0 INTRODUCTION

Cairn India Ltd. (CIL) is the operator on behalf of itself and Joint Venture (JV) partner Oil & Natural Gas Corporation (ONGC) Ltd., of the onshore block RJ-ON-90/1 (the "Block") located in Barmer district, in the state of Rajasthan, India. The Block contains a number of major oil discoveries including the Mangala, Bhagyam & Aishwarya fields (MBA) in the north, and Raageshwari Gas Field on the southern side.

CIL seeks Expression of Interest under International Competitive Bidding Process from reputed Contractors (Domestic and International both) with demonstrated HSE performance to express their interest to participate in the Pre-Qualification for the Installation Works for "MPT-MS1 Reject Water Pipeline System"

2.0 BRIEF SCOPE OF WORK

The Project shall broadly involve installation of a Reject Water Pipeline System from MPT to MS1 complete with applicable hook-ups/tie-ins with station facilities with following parameters:-

Pipe Size : 10" NB

• Length: Approx. 5 – 7 kms

Material: Carbon Steel with External Corrosion Coating

Construction: Trenched & Backfilled

The said pipeline is proposed to be installed in the existing corridor / ROU of CIL in the vicinity of other existing operating pipelines and utilities. The Carbon Steel pipes with 3LPP external coating and other items including mainline valves, flanges, fittings, OFC etc. shall also be free issued by CIL.

The Scope of Work for Installation Contractor shall broadly include construction surveys, provision of construction consumables, trenching, welding/NDT, fabrication/installation/backfilling, hydro-testing, precommissioning and commissioning assistance of the "Reject Water Pipeline System".

Only those Contractors who possess substantial and proven track record of execution of pipeline projects of similar nature, magnitude, complexity and meet the "Specific Pre-Qualification Criteria" defined below shall respond to this EOI.

3.0 SPECIFIC PRE-QUALIFICATION CRITERIA"

3.1 TECHNICAL

(i) The Bidder shall have successfully installed, in last 5 years (reckoned from the date of publication of this EOI), at least one onshore steel pipeline project (size 6" or above and length 2.0 km or above) in one Single Order having demonstrated all aspects of execution of onshore pipeline project including project management, trenching, welding/NDT, fabrication/installation, backfilling, execution of road crossings, Hydro-testing, pre-commissioning, and commissioning etc. complete. Only completed projects shall be considered for evaluation.

3.2 FINANCIAL

- (i) The average turnover of the Bidder in the immediately preceding two financial years should be equal to or more than estimated average annual contract value.
- (ii) The Bidder shall have had a positive net worth in each of the immediately preceding two financial years.

4.0 Documents to be furnished in the EOI Proposal for Pre-Qualification

The Bidders seeking Pre-Qualification for aforementioned Works are requested to submit the following documents and details, for evaluation by Company:-

- 1 Letter of interest for participation in the EOI for pre-qualification for "Installation of Reject Water Pipeline System from MPT to MS1". The Bidder's submission shall clearly identify following:-
 - (i) The Name, Address, Contact Details of the "Bidding Entity".
 - (ii) The Confirmation to take overall responsibility for installation of Reject Water pipeline system.
 - (iii) The Confirmation that the pipeline construction works shall be performed by the Bidder himself and shall not be sub-contracted further.
- 2 **Prequalification Project details:** Bidder to furnish the details as per Annexure-1.
- 3 **Bidder's Past experience** including listing of projects of similar nature and magnitude successfully executed in the last five (5) years and those of currently under execution. (Refer Annexure-2).
- 4 **Bidder's Organization Details** including detailed information of Organization structure, Ownership details, list of manpower and resources, spread (equipment & machinery) details etc.
- 5 **Bidder's proposed Execution methodology**, including the identification of agencies (as applicable) that will carry out the following activities:
 - a. Surveys
 - b. Supply of Field Joint Coatings
 - c. Cathodic Protection Works
 - NDT/Inspection, hydro-testing and pre-commissioning
- Bidder's QHSE System including List of policies, procedures and copies of valid QHSE accreditation certificates for ISO 9001, ISO 14001, BS OHSAS 18001 etc. Bidder to also submit the HSE statistics (including LTIFR track record) covering the last Five (5) years.
- 7 **Financial performance documents** (Audited Balance sheets, Profit and Loss statements etc.) for last two (2) financial years.
- 8 Procurement, fabrication and testing capabilities & infrastructure associated with installation of a steel pipeline system of similar nature and magnitude.
- 9 Procedures/ Systems for subcontractors & vendors evaluation and appointment.
- Reference to demonstrate knowledge & capability for similar jobs under Indian Statutory and Regulatory requirements.
- 11 Details of litigations in last 5 years
- 12 Any other document in support of pre-qualification.

Further to this, interested bidders would be invited to submit their response via Smart Source (Cairn's e-Sourcing Platform).
