**TECHNICAL:** 

1. Company Profile: - Detail company information with Organization structure, client list, CV's of manpower shall be submitted. Planning engineer, E&I, Civil and Construction Engineers shall have 7 to 8 years of relevant experience in Oil & Gas project management and construction. Sr. Project Engineer and HSE Engineer shall have minimum of 10 Years and 5 Years in the Oil & Gas Industry respectively.

2. Company's HSE Pollicy.

3. Quality assurance and quality control practices currently in place. ISO 9001 is mandatory.

4. Accident/Incident statistics for past 5 years.

5. Bidder to have good mobilization record for personnel. Past track record shall be submitted by bidders. Average mobilization period of 15 days is preferable and beyond 30 days is not acceptable.
