EXPRESSION OF INTEREST (EoI) FOR VARIOUS CIVIL WORKS IN RAJASTHAN BLOCK (RJ-ON-90/1)

Cairn Energy India Pty Ltd. ("CEIL") is the Operator on behalf of Joint Venture partners CEIL, Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation (ONGC), of the Contract Area RJ-ON-90/1 at Barmer in the state of Rajasthan. The RJ-ON-90/1 Block contains a number of major oil discoveries. CEIL is intend to carryout drill site and associated facilities construction spread across the field spanning over three (up to Y 2015)

The work scope would broadly consist of drill sites, associated facilities and access roads construction and buildings. It predominantly comprises of drill sites of heavy duty premix designed (GSB,WMM) gravel pads, access roads, installation of shallow well conductor casing using rig, Rig RCC foundations, well cellars, HDPE lined mud pits and buildings. CEIL intends to execute through multiple agencies and shall be decided based on number of rigs and the schedule of production of drill sites

CEIL on behalf of its joint venture partner's invites reputed Civil/Construction Contractors with requisite experience of said civil works, predominantly with NH/SH/ broader roads experience with demonstrated HSE performance to express their interest to participate in the pre qualification as bidders and to participate under National Competitive Bidding ("NCB") process. In view of the nature of the scope, CEIL will consider empanelment under the following categories:

Category 1: only Companies possessing the requisite and proven record of performance in executing civil works or similar works directly (or through sub contractors), with at least three jobs of value exceeding INR 10 Crores each in last three (3) years and having average annual turnover of INR 30 Crores in last two (2) years should respond to this notice.

Category 2: only Companies possessing the requisite and proven record of performance in executing civil works or similar works directly, with at least three similar jobs of value exceeding INR 50 lakh each in last three (3) years and having average annual turnover of INR 1.5 Crores in last two (2) years should respond to this notice.

Companies are requested, as a minimum, to submit the following documents and details for pregualification:

- 1. Letter of interest clearly indicating the Project reference
- 2. Detail of Company Information with Organisation structure, Ownership details, List of manpower with CVs of key personnel in Management, HSE and Construction Operations, Plant and Machinery details.
- 3. Details of completion of similar type of projects in the last three years under headings:

 - (a) Brief scope of work (b) Value of work in INR (c) Contractual Duration (d) Actual completion of Project (e) Clients name (f) Contact details of the Client (CEIL may approach the client directly for the feedback)
 - (g) Safety Certification / Inspection of plant and machineries (h) HSE statistics, LTI graph. (i) Completion Certificate (j) project planning and Execution methodology (k) Listing of Construction Plant and Equipment owned
- 4. List of all jobs currently under execution phase with the value of the Job and percentage
- 5. Experience of working in remote onshore location & desert terrain.
- 6. HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years.
- Quality assurance & Quality control practices currently in place for the execution of similar work.
- Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years.
