GLOBAL EXPRESSION OF INTEREST (EoI) FOR SUPPLY OF HDPE PIT LINERS FOR RAJASTHAN BLOCK (RJ-ON-90/1)

Cairn Energy India Pty Ltd. ("CEIL") is the Operator on behalf of Joint Venture partners CEIL, Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation (ONGC), of the Contract Area RJ-ON-90/1 at Barmer in the state of Rajasthan. The RJ-ON-90/1 Block contains a number of major oil discoveries. CEIL intends to carry out drill site and associated facilities construction work spread across the field.

(i) Completion Certificate (j) project planning and Execution methodology (k) Listing of Construction Plant and Equipment owned
- 4. List of all jobs currently under execution phase with the value of the job and percentage completion
- 5. Experience of working in remote onshore location & desert terrain
- 6. HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years
- 7. Quality assurance & quality control practices currently in place for the execution of similar work
- 8. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years
