Well Testing /Flow Back shall be carried out for almost 300 oil and gas wells over a period of 3 years. The equipment must be suitable for sand cleaning out jobs. The company shall be able to demonstrate full understanding of Indian and internationally accepted Health, Safety and Environmental practices, procedures and policies. - 4. The contractor shall submit details of his Management, Operating and Maintenance schemes with copies of their certification.
- 5. Design and manufacturing capability as per API/ISO specifications.
- 6. Regional capability
- 7. The Contractor must demonstrate that they have sufficient financial standing to commence and continue the operation.
- 8. Have an appropriate comprehensive Health, Safety and Environment management system in place which promotes, aligns with and upholds CEIL's and the Contractor's HSE commitments. Details and copies of their certification must be submitted.
