## EXPRESSION OF INTEREST (EOI) FOR MEDICAL STAFFING AND AMBULACE SERVICES IN RAJASTHAN, INDIA

Cairn India Ltd. ("CIL") is the Operator on behalf of its Joint Venture Partners namely Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation (ONGC) for the Contract Area RJ-ON-90/1 at Barmer in the State of Rajasthan (Block). The Block contains a number of major oil discoveries namely Mangala, Bhagyam, Aishwariya, and other fields. The Mangala field is the largest onshore oil discovery in India since 1985. Mangala Processing Terminal (MPT) is the common processing hub for Mangala, Bhagyam, Aishwariya and other smaller fields.

It is critical for emergency patients to be stabilized as fast as possible, using an on-site medical facility together with fully trained medical personnel. In addition, maintaining the optimum health of personnel working on the site is of paramount importance.

CIL seeks Expression of Interest (EOI) from suitably experienced contractors to meet the medical services requirement. The duration of contract shall be 2 years with an option of extending the same to another one year in Two Slots of Six (06) month each at same rate, term and conditions for the complete activities of medical services viz. medical staffing of doctor, paramedic and ambulance as per **Table 1**.

Contractors meeting the following requirements are eligible to apply:

- The contractor should have executed similar kind of services for Oil &Gas plants for a minimum of 3 years.
- The average annual turnover of the company in the last 3 years shall be INR 10 Crores.
- Undertaking of the agency confirming the availability of the adequate manpower of requisite qualification and experience for deployment at CIL, Rajasthan job sites.
- Undertaking of the agency confirming the deployment of ambulance as per Cairn Specifications.

In brief, the scope of work shall include:

## Services included but not limited to the following:

The Works shall be located in districts of Barmer and Jaloredistricts of Rajasthan State. The field is approximately 220 km. South-West of Jodhpur city.

- The Contractor shall provide qualified and experienced medical doctor, paramedic and Ambulance drivers at three Sites (at MPT, Bhagyam and RGT- see Table1). They shall be medically fit. Their CVs shall be approved by CIL before employment. Company may carry put personal interview at its own discretion before approving the CV. The Crew Change pattern will be once every 21 days.
- Two advance life support ambulances on sites one each at Bhagyam and RGT.
- To ensure and manage health care activities as per the duties listed out for each member staff.
- To manage biomedical waste as per Government Regulations.

The Contractor shall provide the following trained personnel (the Medical Team) at three locations, together with fully fitted out ambulance(s) (as specified hear in) for a period of two years:-

Contractor shall provide skilled work force along with the required resources necessary to carry out medical and health activities as per the schedule of rates without any additional cost to CIL.
