Expression of Interest (EOI) for supply of accommodation & office bunk houses at various fields in Rajasthan.

Caim Energy India Pty Ltd. ("CEIL") is the Operator, on behalf of its Joint Venture Partners namely Caim Energy Hydrocarbons Limited and Oil and Natural Gas Corporation (ONGC) for the contract area RJ-ON-90/1 at Barmer in the state of Rajasthan (Block). The block contains a number of major oil discoveries namely Mangala, Bhagyam, Aishwariya, and other fields. The Mangala field is the largest onshore oil discovery in India since 1985. The Mangala field is currently producing 125,000 bopd and the developments of Bhagyam and Aishwariya are progressing well. Mangala Processing Terminal (MPT) is the common processing hub for Mangala, Bhagyam, Raageshwari, Aishwarya and other smaller fields.

CEIL proposes to buy accommodation bunk houses, office bunk houses and other infrastructure bunk houses like dining hall, kitchen, toilets etc. The quantity of bunks shall be approximately 100 nos of various sizes. In view of this, CEIL on behalf of its Joint Venture Partners seeks an Expression of Interest under Competitive Bidding process from reputed Companies with demonstrated performance for pre-qualification to participate in the competitive bidding process for Supply of the Bunk Units.

Broad scope for the successful company shall include manufacturing of the bunks as per CEIL scope of supply, transportation to site, installation including plumbing & electrical works and made ready for accommodation.

Interested companies are requested to submit the following documents and details as per the criteria defined below.

- Letter of interest with detailed company information like organisation structure, list of key personnel with qualifications and experience, details of the available work force & competency levels
- Accreditation to ISO 9001:2008 / ISO 14001: 2004 / ISO 18001: 2007 Certification
- Quality assurance and Quality control practices currently in place for the execution of similar work.
- Company's financial performance documents (Audited Balance Sheets and Profit and Loss Statements etc.) for last 3 years.
- Details of any court receivership or similar proceedings.
- HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years
- List of contracts executed in last 10 years and those currently under execution.
 - a. Value of work in USD
 - b. Name of the clients/customer
 - c. Contact details of the client/customer
 - d. Any other relevant information.
- Company must have the following:
 - a. Manufacturing and in-house fabrication yard & inspection capability. Minimum area allocated to this tender for fabrication / manufacturing shall be of the order of 200000 Square Feet.
 - b. Should be in the business of Bunk Houses manufacturing for more than 10 years.
 - c. Highly experienced and qualified Works Manager with at least 10 years of experience in Manufacturing
 - d. The factory operations shall be backed up by own captive power.
 - e. Adequate number of supervisors and workers to undertake timely work.
 - f. Enough storage area to smoothly undertake logistics of the Bunk Houses.
 - g. Company must have of its own a fabrication workshop, machinery, storage areas, office setup, communication set-up between the fabrication workshops and the supporting engineering offices, product engineering &

design capability, design certification, codes & standards

- Annual turnover of the company shall be US\$ 4.5 million during any of the preceding 5 financial years.
