EXPRESSION OF INTEREST (EOI) FOR SCAFFOLDING SERVICES IN RAJASTHAN, INDIA

Cairn India Ltd. ("CIL") is the Operator on behalf of its Joint Venture Partners namely Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation (ONGC) for the Contract Area RJ-ON-90/1 at Barmer in the State of Rajasthan (Block). The Block contains a number of major oil discoveries namely Mangala, Bhagyam, Aishwariya, and other fields. The Mangala field is the largest onshore oil discovery in India since 1985. Mangala Processing Terminal (MPT) is the common processing hub for Mangala, Bhagyam, Aishwariya and other smaller fields.

To meet the resource requirement CIL intend to award contract for scaffolding services to interested competent party. The brief scope of work of the contractor under this contract is to carry out scaffolding works as per the requirement of CIL for its Rajasthan asset including MPT, Bhagyam, Aishwariya and RGT.

CIL seeks Expression of Interest (EOI) from suitably experienced contractors to meet the scaffolding services requirement. The duration of contract shall be 3 years with an option of extending the same to another one year in Two Slots of Six (06) month each at same rate, term and conditions.

Contractors meeting the following requirements are eligible to apply:

- The contractor should have executed similar kind of services for Oil & Gas plants for a minimum of 5 years.
- The average annual turnover of the company in the last 3 years shall be INR 4 Crores.
- Organizational strength, Availability of adequate manpower of requisite qualification.
- The net worth of the company should be positive.
- Document poof of certified scaffolders from reputed Institute / Authority

In brief, the scope of work shall include:

Services included but not limited to the following:

- To carry out scaffolding at various locations as per requirement of CIL, stages of scaffolding vary as per necessity.
- Supply of scaffolding pipes, grating/planks for platforms, toe-guards, small length pipe for hand railings, universal clamps for pipe to pipe clamping and beams to scaffolding pipe clamping, scaffolding tags, all safety harness, roll-gliss, inertia reel.
- Supply of manpower resources with good skills and ability to work in heights is essential.
- Contractor has to deploy a minimum manpower of 18 (1 scaffolding inspector, 1 supervisor and 16 scaffolders) but not limited to for executing the minimum quantity job of 2000m3 per month.
- Scaffolding supervisor should be certified scaffolders from reputed agencies.
- Stacking and storage of pipe & clamps will be done at designated areas only.
- Contractor should follow OSHA 1926 scaffold standards
- Measurement for scaffolding will be taken from last landing platform guardrail up to 1 meter height only.
- If scaffolding erected above 25 meters, it should be inspected by authorized TPI.
- The contractor is carrying out scaffolding work as per CIL requirement with all material (at least 4000 cubic meter inventory to be maintained at site) in his scope only.
