GLOBAL EXPRESSION OF INTEREST FOR ETP AUGMENTATION AT CB/OS-2 ONSHORE FACILITY

Cairn India Ltd (CIL) is the Operator of CB/OS-2 block located on the west coast of India on behalf of its joint venture partners ONGC Limited, Tata Petrodyne Limited & CIL.CIL invites expression of interest from interested parties for the Augmentation of Effluent Treatment Plant (ETP) at CB/OS-2 Onshore Facilities (Hazira, Surat).

The augmentation is to be done in the existing ETP of 20m3/hr capacity, which includes installation of equipments such as Air saturation unit, Biological Treatment units (SBR), Polishing system with Ozonation, Sand & carbon filters, sludge drying bed, etc. The scope of the LSTK contractor includes design, engineering, construction, installation, integration with existing facilities, testing & commissioning of all electrical, instrumentation, mechanical equipment & accessories, associated civil works, etc. related to the ETP augmentation project.

Those bidders possessing substantial and proven record in design, engineering, construction, installation, integration and commissioning of ETP on LSTK basis shall submit their expression of interest along with the following pre-qualifications documents. Parties with direct work experience in Oil and Gas industries would be preferred.

- 1. Letter of interest with detailed company information.
- 2. Details of Organogram along with managerial, supervisory, skilled manpower and available other staff to manage the project
- 3. Details of similar projects executed in the last five years and those of currently under execution with project name, client's name, brief scope of work, contract value, completed man hours, contractual & actual completion date with completion certificates, client certification, client references & contact details (with emphasis on work carried out in Oil and Gas sector).
- 4. List of policies, procedures and quality assurance and quality control practices currently in place for execution of similar work
- 5. HSE policies, implementation procedures in line with accepted practices.
- 6. Contractor should have executed similar at least one project of value \$ 0.7 MM in last three years.
- 7. Average annual turnover of the Contractor shall not be less than \$ 1.4 MM in last three years.
- 8. Company's financial performance documents i.e audited balance sheets, profit and loss account & cash flow statement, etc. for last 03 years
