



EXPRESSION OF INTEREST (EOI) FOR CONSTRUCTION OF BOAT LANDING FACILITY AT BHOGAT

Scope of work broadly includes **Construction of boat landing facility at Bhogat** to demonstrated capability to mobilize equipment/ machinery/ resources required for construction of jetty within agreed timelines

Financial GO/NO-GO Criteria

- a. Turnover Turnover in each of the immediately preceding two (02) financial years should be equal to or more than the estimated Average Annual Contract value.
- b. Net Worth Positive net worth in each of the immediately preceding two (02) financial years.
- c. Liquidity Ratio Liquidity ratio in each of the preceding two financial years shall not be less than 1.

Technical GO/NO-GO Criteria

(A) Minimum of Five (05) years' experience (in preceding Ten (10) years) in construction of Jetty/Marine offshore construction at Manufacturing plants/Oil & Gas/Petrochemical/Cement plants/Fertiliser Industry/Large Scale industries at work site locations.

(B) Each bidder should demonstrate experience of at least 3 Marine/offshore construction/Jetty projects.

(C) Bidder should have necessary licences from GMB and other government bodies.

Also, note

i. Normally standalone financials of the bidding entity only will be considered. However, consolidated financials at the bidding entity level, if available, can also be submitted. Parent company or Affiliate's financials can be submitted and considered, subject to submission of Parent/Affiliate company guarantee. This should be clearly mentioned in the EOI response.





- ii. Where the bidding entity is unable to meet the Financial Evaluation Criteria, Parent/Holding Company Audited Financials can be considered, subject to:
 - a) Submission of Financial guarantee in the form of 10% Bank guarantee of Annualized Contract Value.b) Commitment Letter from Parent/Company to provide financial support to the bidding entity.
- iii. Evaluation will be done only on the basis of the published annual reports / audited financials containing Auditor's report, Balance sheet, Profit & Loss a/c and Notes to Accounts.
- iv. In case of unaudited statements (if there are no audit requirements for auditing of financials as per the local law), the financials shall be accompanied by a certificate from a Certified Accountant. Certificate should also mention the fact that there is no requirement of audit of the financials as per the local law.

All qualifications and exceptions brought out in Auditor's report and Notes to Accounts would be factored in while undertaking financial evaluation
