Only those Bidders who, as a standalone entity or consortiums meet the below criteria should respond to this EOI:

"SPECIFIC PRE-QUALIFICATION CRITERIA"

- Has the experience/capability (either by self or through subcontractors) in Provision of Third-Party services for Quantity Surveying, Invoice certification & SAP Co-ordination, Third Party Inspectors for Quality Assurance & Quality Control (Domestic & Overseas), Lab Testing & WPS establishment, QHSE Engineers & Permit Coordinators, TPI Lifting Specialist, HSE Competency Training, Commissioning supervision for the surface facility at offshore platforms / onshore well pads / Processing Terminals for past 10 years either in LSTK or single service contract.
- 2. Turnover in each of the immediately preceding two financial years should preferably be equal to or more than the estimated average of the contract value.
- 3. Net worth should be preferably positive in each of the immediately preceding two financial years.
- 4. Liquidity ratio should preferably be not less than 1 in each of the preceding Two (02) financial years.





Interested parties are also requested, to submit the following documents and details as a minimum:

- 1. Letter of interest from interested party on their Letter Head.
- 2. Detailed contractor information clearly specifying years of experience in similar jobs, organization structure, list of testing facilities, plant and machinery list mentioning year of manufacturing, support agencies and other facilities and resources for relevant scope.
- 3. List of current ongoing contracts of similar nature under execution.
- 4. Project Execution & Management / Planning & Scheduling methodology
- 5. Demonstrate Technical and Managerial resource availability of including capabilities along with organogram and resource responsibility.
- 6. Details of services provided last 05 years of Quantity Surveying / cost consultancy / invoice certification in in India / Asia.
- 7. Details of TPI QA/QC services provided (Domestic & Overseas) last 05 years and QA/QC TPI centres in India / Asia / Far East / and mentioned countries in the SOW for Overseas TPI services to extend prompt service support.
- 8. Demonstrate services provided last 05 years for Lab Testing & WPS establishment and Testing capacities & capabilities along with list of testing procedures.
- 9. Details of services provided last 05 years for provision of QHSE / Lifting specialist/ Commissioning Engineers.
- 10. Details of services provided last 05 years for provision of Supervision services.
- Health Safety and Environment (HSE) policies, HSE Safety Manual / Procedures, HSE Organogram in-line with internationally accepted practices and HSE performance statistics (LTIFR, FAR, MVAFR) for last five (05) years.
- All HSE related documents shall be submitted as per the Cairn Quality & HSE Risk criteria defined in Scope of Work.
- 13. Updated Quality Manual, Policies and Procedures, Quality organogram in line with internationally accepted practices along with list of quality trained resources and competency matrix
- 14. Copies of valid ISO certifications for ISO 9001: 2015, ISO 14001:2015, OHSAS 18001: 2007/ ISO 45001:2018, other statutory certification like DGMS, ASME U / R stamp, API Q1 9th editions/ API Q2 1st edition etc. for the intended scope of work / services (as applicable).
- 15. Proven Track Record of catering similar services for last 05 years.
- 16. Procedures/ Systems for subcontractors & vendors evaluation and appointment.
- 17. Details of litigations in last 05 years.

EOI submission shall be complete with the above requested information. The interested parties should evince interest to participate in the Expression of Interest by clicking on the "Evince Interest" link against the corresponding EOI listing on the Cairn's website and submit their contact details online. Further to this, interested parties would be invited to submit their response via Smart Source (Cairn's e-Sourcing Platform).
