1. Annual Turnover in each of the immediately preceding two (2) financial years should be greater than or equal to estimated Average Annual Contract Value.
2. Positive net worth in each of the immediately preceding two financial years.
3. Liquidity ratio shall not be less than 1 in each of the preceding Two (02) financial years.
4. Contractor shall have a minimum of 03 years (in preceding 7 years) experience in operation and maintenance of similar Polymer or Powder based Mixing & Blending Facilities with Solid Handling Capacity >25000 MT per annum having Chemical or Polymer Blending/Preparation units in Oil & Gas processing / Refining / Petrochemical / Chemicals.
