

EXPRESSION OF INTEREST (EoI) FOR OPERATION & MAINTENANCE SUPPORT SERVICES FOR THREE YEARS AT MPT, BARMER, RAJASTHAN

Cairn India Ltd ("CIL") is the Operator of the Onshore **RJ-ON-90/1** block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

The scope of work/ services would broadly consist of the following:

To meet the resource requirement CIL intend to award contract for Operations & maintenance support services for operations at MPT, Barmer Rajasthan to interested competent party. The brief scope of work of the contractor under this contract is to establish contract for Operation & maintenance support services (instrumentation, mechanical & electrical) for 3 years as per the requirement of CIL at MPT, Barmer, Rajasthan.

Work Overview:

Contractor shall provide operation & maintenance support services (instrumentation, mechanical & electrical) to support Operations at MPT, Barmer, Rajasthan. The Contractor shall supply suitable resources as per the desired qualification to provide assistance for Three year from the date of placing the contract.

Operations & maintenance support Services include but not limited to the following:

Instrumentation Engineer, Instrumentation Technician, Instrumentation Fitter, Mechanical Engineer, Mechanical Technician, Mechanical fitter, Civil engineer, Electrical engineer and Electrical technician

The following parameters are to be considered while responding to the EOI

Only those companies / consortium possessing substantial and proven record of fulfilling below mentioned **Go-No-Go criteria** needs to apply.

- The average annual turnover of the company shall be INR 17 Cr. or more for the last 02 financial years.
- Net worth of the company shall be at least INR 1.70 Crore in preceding two financial years.
- Liquidity ratio shall not be less than 0.75 in the past 02 years.
- Contractor shall have a minimum of 5 years of experience in providing similar services in the field of Oil & gas processing, Petrochemical, and Refinery, Steam generation & Power plants and Utilities system.
- Company's financial performance documents (Audited balance sheets and Profit & Loss statements etc) for last 2 years (FY-13 & FY 12).



Companies are requested, as a minimum to submit the following documents and details:

- (1) Company organization structure with Total Strength
- (2) HSE track record.
- (3) Details of current commitments

Quality Systems:

- (4) Copy of current ISO Certificate provided
- (5) Certification of the companies QA system by an accredited certification body
- (6) Company registration details, PF, ESI . Pan card, Service tax CST / VAT , details etc.. Company Registration
- (7) The contractor should have executed / supplied similar kind of operation & maintenance support services for Oil & Gas Companies with client completion certificates.

CIL on behalf of the JV partners invites reputed contractors with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in Competitive Bidding Process. In view of the nature of the scope, only those Companies complying the requirements and proven record of performance should respond to the EOI.
