Introduction

Scope of Work:

The scope of work under this contract is the provision of providing rig inspection services and full conditional surveys for both land and offshore drilling/ workover rigs across various blocks of 'CIL' in India.

The scope shall be to perform a conditional survey of the primary drilling equipment, mud system, well control equipment, marine equipment, power plant, electrical equipment, safety equipment, maintenance system and the spare parts. The inspections shall be focused on total quality management systems including drilling, marine, health safety and environment and preventative maintenance systems.

The bid package will be inclusive of all required manpower, manpower movements and accommodation and provisioning for same in and outside of the area of operations.

- Organizational structure, detailing their nominated management, staff and business process support to carry out the Services.
 - Details of completion of similar type of jobs in the last five years
 - Single largest value of Contract executed in the last five years
 - A demonstrable capability to commence work to meet the schedule of CIL. The Contractor's experience in completing the work on schedule shall be clearly stated.
 - Have an appropriate and comprehensive Health, Safety and Environmental management system in place which promotes, aligns with and upholds the commitments of CIL and the Contractor. Details of their certification shall be submitted.
 - Willingness to develop a close long term relationship with CIL
 - Sound HSE policy in place.
 - Quality assurance & Quality control practices currently in place for the execution of similar work
 - Audited financial statements for the last three years
 - Contractor must demonstrate that they have sufficient financial standing to commence and continue an operation of this magnitude
