## EXPRESSION OF INTEREST (EOI) FOR THROUGH TUBING WELL INTERVENTION SERVICES IN RJ-ON-90/1 BLOCK

Cairn Energy India Pty Ltd. ("CEIL") is the Operator on behalf of Joint Venture partners CEIL, Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation (ONGC), of the contract area RJ-ON-90/1 block at Barmer, in the state of Rajasthan. The RJ-ON-90/1 block contains oil discoveries namely Mangala, Bhagyam, Aishwarya and Raageshwari and others. The well services operations in Rajasthan cover a varied and broad spectrum of routine and non routine, well intervention and well remedial practices. To effectively cope with the challenges, the well services are equipped with three (3) modes of well bore conveyance.

- 1) Coiled tubing.
- 2) Slick Line.
- 3) E Line.

The well services currently operate two (2) dedicated coiled tubing units, two (2) E-line units and four (4) slickline units in Rajasthan.

Being a wide spectrum of opportunities with a high quantum of work, through this Expression of Interest (EoI) the company intends to invite vendors who are interested in providing below mentioned Through Tubing Well Intervention services/ equipment under a rate contract. Interested vendors are requested to submit their EoIs only if they provide the following services either full or in part.

- Standard tools, like MHA, disconnect, back pressure valves, etc for Coil Tubing.
- Fishing tools conveyed by CT or Slickline.
- Cleanout tools conveyed by CT, Eline or slickline (nozzles, rotating nozzles, displacement nozzles, downhole junk catchers etc).
- Permanent and retrievable inflatable packers / bridge plugs/ Straddle packers conveyed by Slickline, Eline or CT.
- Milling and drilling motors, tools, various mills, reamers and bits conveyed by CT.
- Jars, accelerators, vibrators, shifting tools, scrappers for CT/ Slickline.
- High power magnets, downhole imaging tools conveyed by CT, Eline or slickline.
- Casing exit tools.
- Tractor services for Eline as well as CT.
- Software / engineering support for modelling and estimating the effectiveness of the above job.
- PLT Tools

This Eol caters to the requirement of tools and equipments for the following different categories of tool/equipments based on conveyance means:

- 1) Coiled Tubing conveyed tools.
- 2) Slick-line conveyed tools
- 3) E-line conveyed tools.
- 4) Tractor and Tractor conveyed tools.

Four different contracts would be placed on a call out rental basis for two (2) years firm with the option of one (1) year extension.

CEIL, on behalf of its joint venture partners invites reputed Contractors who are specialised in the above mentioned services, and with demonstrated HSE performance to express their interest to participate in the prequalification as bidders and to participate in the competitive bidding process. In view of the nature of the scope, only those Companies possessing the requisite and proven record of performance in the last five (5) years may submit their expression of interest.

In addition to the above requested documentation, bidders should also submit credentials to support the specific qualification criteria for each package.

Companies are requested, as a minimum, to submit the following documents and details for prequalification:

- 1. Letter of interest clearly indicating the project reference
- 2. Detail company Information with organisation structure, list of manpower with CVs of key personnel, support agencies and other facilities & resources.
- 3. In-house product development capabilities.
- Details of completion of similar type of projects in the last five years under headings:

   a) Brief scope of work b) Value of work in INR c) Contractual Duration d) Actual completion of Project e) Clients name f) Contact details of the Client ( CEIL may approach the client directly for the feedback) g) Safety / Inspection certificates of the equipment) HSE statistics, LTI graph, Testimonials etc.
- 5. Typical job Planning and Execution methodology.
- 6. List of all jobs done in the past with other clients.
- 7. Experience of working in similar terrain.
- 8. HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years.
- 9. Quality assurance & Quality control practices currently in place for the execution of similar work.
- 10. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years.
