

GLOBAL EXPRESSION OF INTEREST FOR SUPLLY, INSTALLATION & COMMESSIONNING OF H2S GAS DETECTION SYSTEM FOR RAJASTHAN BLOCK

Cairn India Ltd ("CIL") is the Operator of the Onshore **RJ-ON-90/1** block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major Oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

The scope of work shall be Supply, Installation & commissioning of:

- Addressable Type Microprocessor based Control System
- Toxic Gas Detector with LCD Display
- 3 LWC-50PPM H2S Gas Cylinder/Calibration tools

To meet the resource requirement CIL intend to award contract for H2S gas detection system to the competent Supplier.

Only those Suppliers meeting the following criteria as a minimum should respond to the EOI:

- Supplier turnover for last Two (2) audited years should be more than i.e. USD 2.57MN.
- Supplier's net worth should be more than \$ 0.257 MN for last Two (2) audited years.
- Liquidity ratio in each of the preceding years shall not be less than 0.75.
- Supplier should be the manufacturer/Authorized distributor of the Gas Detector and having at least 3 years of experience in supply and installation in Oil & Gas industry.

Companies are requested, as a minimum, to submit the following documents and details:

- Detail Company information with Organization structure, List of manpower, Parent company, Plant & machinery list mentioning year of manufacture, support agencies and other facilities and resources.

List/ Details of similar type of projects successfully executed in the last Five years and similar projects/agreements currently under execution under headings a) Brief scope of work b) Value of work c) Contractual duration d) Actual completion of project e) Client name f) Contact details of client (CIL may approach the client directly for feedback) with the completion certificates, PO, LOI or contract Copies.
- 3. Client reference list.
- 4. Supplier shall submit financial audited statement for the year FY-12 and FY-13.
- 5. Typical project planning and execution methodology
- 6. Details of capability to mobilise and commence work to meet CIL's schedule. The Contractor's experience in mobilising on schedule should be clearly stated.
- 7. Details of Particular experience of providing Services in remote areas where rapid mobility and flexibility to accommodate CIL's programme is paramount. Evidence supporting successful major operations in remote areas must be submitted.
- 8. List of policies, procedures and quality assurance practices currently in place for the execution of similar work.
- 9. Health, Safety and Environment (HSE) policies, procedures, manual in line with internationally accepted practices and HSE statistics covering the last 3 years



- 10. HSE Certification OHSAS 18001.
- 11. Quality assurance & Quality control plan/ procedures in place for the execution of similar type of work, Copy of ISO 9001 and 14001 or any other certification as applicable.
- 12. Copy of registration certificates (Labour law, EPF, Registration etc)
- 13. Business presence in the region
