**GLOBAL EXPRESSION OF INTEREST FOR PROVISION OF COMPREHENSIVE PROCESS  
CORROSION STUDY AT RAJASTHAN BLOCK**

Cairn India Ltd (“CIL”) is the Operator of the Onshore **RJ-ON-90/1** block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

The scope of work/ services would broadly consist of the following:

To meet the resource requirement CIL intend to award contract for Corrosion study interested competent party. The brief scope of work of the contractor under this contract is to carry out Corrosion study as per the requirement of CIL for Rajasthan asset.

**Only those Companies meeting the following criteria as a minimum should respond to the EOI:**

- Contractor turnover for last Two (2) audited years shall be \$ 1.9mm.
- Contractor positive net worth for last Two (2) audited years shall be \$ 0.19mm.
- Contractor’s has to submit track record of similar corrosion study for at least 3 oil & gas company in last 5 years
- This project specific HSE requirements

**The contractor is responsible for the Corrosion Study involving the following:**

1. To complete the corrosion study/ assessment by site visits, carrying out ICDA and to identify key corrosion areas with clear recommendations to mitigate corrosion threats to maintain corrosion rate < 3 mpy.
2. The entire corrosion study scope will be completed in 3 phases
3. The corrosion study is a time bound activity and to be completed in 8 months’ time from the start date of Phase I study.
4. The contract is applicable for Mangala infield assets and interconnecting pipelines Contract by its technical methodology has been split into phases at sole discretion of company.

In addition to the above requested documentation, bidders shall also submit credentials to support the specific qualification criteria for the package.

Companies are requested, as a minimum, to submit the following documents and details:

1. Detail Company information with Organization structure, List of manpower with CV's of key personnel, Parent company, Plant & machinery list mentioning year of manufacture, support agencies and other facilities and resources.
2. List/ Details of similar type of projects successfully executed in the last three years and similar projects/agreements currently under execution under headings a) Brief scope of work b) Value of work c) Contractual duration d) Actual completion of project e) Client name f) Contact details of client (CIL may approach the client directly for feedback)
3. Typical project planning and execution methodology
4. Details of capability to mobilise and commence work to meet CIL's schedule. The Contractor's experience in mobilising on schedule should be clearly stated.
5. Details of Particular experience of providing Services in remote areas where rapid mobility and flexibility to accommodate CIL's programme is paramount. Evidence supporting successful major operations in remote areas must be submitted.
6. List of policies, procedures and quality assurance practices currently in place for the execution of similar work.
7. Health, Safety and Environment (HSE) policies, procedures, manual in line with internationally accepted practices and HSE statistics covering the last 3 years
8. Quality assurance & Quality control plan/ procedures in place for the execution of similar type of work, Copy of ISO or any other certification as applicable.
9. Copy of registration certificates (Labour law, EPF, Registration etc)
10. Business presence in the region

The interested suppliers should evince interest to participate in EoI within 14 days of publication of Expression of Interest.
