## EXPRESSION OF INTEREST (EoI) FOR PROVISION OF INTEGRATED SURVEY AND ASSOCIATED ENGINEERING SERVICES FOR RJ-ON-90/1 BLOCK

Cairn India Ltd. ("CIL") is the Operator on behalf of itself and its joint venture partners Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation Limited (ONGC), of the onshore block RJ-ON-90/1 at Barmer in the state of Rajasthan. The RJ-ON-90/1 Block contains a number of major oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields. CIL intends to carryout survey and associated engineering services for various sites across the block.

CIL on behalf of itself and its joint venture partners invites reputed contractors with demonstrated HSE performance to express their interest to participate in the pre-qualification as bidders under National Competitive Bidding ("NCB") process for the services listed below:

- Topographical survey of proposed site locations using Land based LIDAR (with DGPS equipment) and development of site layouts
- Site selection through desktop study, field reconnaissance survey and detailed digital terrain mapping
- Engineering services including issue of engineering drawings for site facilities: Bill of Quantities (BOQ) for cut & fill calculations for earthworks, approach road engineering and design, etc.
- Providing a senior survey co-ordinator at our Head office in Gurgaon for overall coordination along with necessary hardware and software.

CIL shall enter into long term frame/ rate agreement for provision of the integrated survey and engineering services for various sites to be executed on call basis.

Only those contractors possessing substantial and proven record for provision of above services of similar scale spread over a wide area preferably in desert terrain should respond to this notice.

Contractors are requested, as a minimum, to submit the following documents and details:

- 1. Letter of interest clearly indicating the Project reference.
- Detail of Company Information with Organization structure, Ownership details, List of manpower with CVs of key personnel in Management, HSE and details of survey equipment, data processing and software/hardware.
- Details of completion of similar type of surveys in the last three years under headings:

   (a) Brief scope of work (b) Value of work in INR (c) Contractual Duration (d) Actual completion of Project (e) Clients name (f) Contact details of the Client (CEIL may approach the client directly for the feedback) (g) Safety Certification / Inspection of plant and machineries (h) HSE statistics, LTI graph (i) Completion Certificate (j) Project planning and Execution methodology.
- 4. List of all jobs currently under execution phase with the value of the Job and percentage completion.
- 5. Experience of working in remote onshore location & desert terrain.
- 6. HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years.
- 7. Quality assurance & Quality control practices currently in place for the execution of similar work.
- 8. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years.
