EOI For Engineering, Procurement And Construction (EPC) Of Living Quarters At Bhogat Terminal In Jamnagar, Gujarat For Mangala Development Pipeline Project (MDPP)

Cairn Energy India Pty Ltd. ("CEIL") is the operator of Block RJ-ON-90/1 (the "Block") in India, and operates the Block on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited and the Oil and Natural Gas Corporation (ONGC). The Block contains a number of major oil discoveries, including the Mangala field, the largest onshore oil discovery in India since 1985.

CEIL has set up and commissioned a 600 km long pipeline, pumping stations, terminals and related facilities for the transportation of 1,50,000 to 1,75,000 barrels of crude oil per day from the upstream process terminal at the Mangala field to the downstream terminal point on the Gujarat coast at Bhogat in Jamnagar District.

Cairn Energy India Pty Limited (CEIL) proposes to develop Living Quarter Facilities for Project Construction and Operations staff. Facilities shall include but not limited to Engineering, Civil, Structural, Architectural, HVAC, Mechanical, Piping, Telecommunication, Instrumentation, Electrical & Plumbing (MEP), Fire Protection works and other associated works.

With this EOI, CEIL invites reputed Construction Companies possessing substantial and proven track record of performance in executing the construction of Living Quarter Facilities.

Only contractors with the following pre-requirements shall bid for this tender:

- 1. Only Gujarat based contractors who have registration in Gujarat not later than January 2009 having their home office based in Gujarat (For clarity, a Company that operates outside Gujarat and registers an office in Gujarat is not considered a Gujarat based one for this purpose).
- 2. Annual turnover of INR 55 Cr in any of the last three years.
- Minimum of 3 years of recent experience in executing the similar project in construction of residential and commercial townships as construction contractors, preferably dealing with Oil and Gas Projects, Exploration or Refineries and Petrochemicals.
- 4. Should be profit earning firm/company for at least three preceding years.
- 5. Should never have been blacklisted by Government/PSU/CEIL/Reputed Company.
- 6. Should be registered with State Service Tax authority.
- 7. Should follow all Health, Safety and Environment (HSE) and Road Safety procedures, and policies of CEIL strictly.

Companies are requested, as a minimum, to submit the following documents and details:

- 1. Letter of interest along with company/consortium information detailing their nominated management, staff, and business process support to carry out a multi-year, major services campaign for all types of Projects facilities.
- List of similar works successfully executed in the last three years and similar projects/agreements currently under execution. (With particular emphasis on work carried out with Oil and Gas industries). Contact details from the earlier projects shall be provided by the bidders.
- 3. List of current contracts of similar nature with contact details of respective clients.
- 4. Details of capability to mobilise and commence work to meet CEIL's schedule. The Contractor's experience in mobilising on schedule should be clearly stated.
- Details of particular experience of providing Services in remote areas where rapid mobility and flexibility to accommodate CEIL's programme is paramount. Evidence supporting successful major operations in remote areas must be submitted.
- 6. Intent to develop a close long term relationship with CEIL.
- 7. List of policies, procedures and quality assurance practices currently in place for the execution of similar work.
- 8. Typical Project Quality plan and proposed organization chart for Project QA/QC.
- 9. Health, Safety and Environment (HSE) policies, procedures and statistics covering the last 4 years which includes Drugs and Alcohol, Security, Personal Protective Equipment, Road Safety, Labour Camp and Staff accommodation, and Waste Disposal.
 - 9.1 EMS 14001 and OHSAS 18001 certificates to be provided. Environment Management Plan to be submitted.
 - 9.2 Has in record LTI Track record for last 3 years (Hours lost). Any safety award / reward / recognition received.
- 10. Corporate financial details for last 3 years.
- 11. Copies of any additional certifications.
