



GLOBAL EXPRESSION OF INTEREST (EOI) FOR ENGINEERING, PROCUREMENT, CONSTURCTION AND INSTALLATION OF CARBON STEEL, DUPLEX STAINLESS STEEL & REINFORCED THERMO PLASTIC (RTP) PIPELINES AT OIL & GAS FACILITIES BARMER, RAJASTHAN

Cairn Oil and Gas, a vertical of **Vedanta Limited** is the Operator at onshore block RJ-ON-90/1 located in Barmer & Jalor Districts in the state of Rajasthan; Offshore block CB/OS-2; located off the west coast of the state of Gujarat; Offshore Block Ravva Oil and Gas Field (Ravva), located off the east coast of the state of Andhra Pradesh.

The Operator on behalf of itself & Joint Venture (JV) partner(s) invites interested contractors (Bidders) with proven capabilities & performance track record in similar requirement to express their interest for prequalification to participate in the Global Competitive Bidding (GCB) Process. The purpose of this GCB is to hire a reputed contractor who can "Design, Supply and Install buried pipelines" for Oil & Gas Facilities Barmer, Rajasthan as per below details.

Scope of Work broadly includes:

Scope is divided into two categories. Bidder to indicate its interest in any or all of the following categories:

Part A: Duplex Stainless Steel (DSS), Carbon Steel (CS)/Carbon steel with HDPE liner Pipelines

- 1) Replacement of existing 14" X 900 Mtr. (Approx.) Duplex stainless steel (DSS) buried pipeline. Externally coated DSS line pipes shall be free issued to the contractor. Brief scope covers, construction including stringing, trenching, Hot/Cold bends, HDD, welding/NDT, joint coating, laying, backfilling, hydro-testing, hook up, pre-commissioning and commissioning etc.
- 2) Replacement of existing pipelines with new CS / CS with inner HDPE liner. Brief scope covers engineering, procurement (including CS line pipes, HDPE liner, Valves, fittings etc.) and construction (including stringing, trenching, welding/NDT, fabrication of flanged spools, construction of flange/valve pits, installation/laying of pipe spool in the trench, backfilling, hydro-testing, hook up, pre-commissioning and commissioning etc.).

Part B: Reinforced Thermoplastic Pipelines (RTP)

Replacement of existing high temperature and high pressure CS pipelines with new multiple RTP pipelines. Brief scope covers engineering, procurement (including RTP line pipes, CS manifold, Valves, fittings etc.) and construction (including trenching, fabrication of manifolds, construction of valve pits/Above ground fencing, installation/laying of pipe spool in the trench, backfilling, hydro-testing, hook up, pre-commissioning and commissioning etc.)

Only those entities who meet the "Specific Pre-Qualification Criteria" as mentioned below are requested to respond to this EOI. The selected consultants would not be permitted to sub-contract the awarded jobs / sections of the job without Cairn's explicit approval.

Interested companies meeting following criteria should respond to this EoI:

- 1. The respondent or their principal (OEM) should have proven track record with minimum 3 years (in preceding 05 years) experience in providing similar kind of services.
- 2. Turnover in each of the immediately preceding two financial years should be equal to or more than the estimated annual contract value.
- 3. Positive net worth in each of the immediately preceding two financial years.

4. Liquidity ratio in each of the preceding Two (02) financial years shall not be less than 0.60.

Note: For Part-B of EOI, RTP manufacturers may also participate.

Bidders are requested to submit the following pre-qualification documents as a minimum:

- ❖ Letter of interest clearly indicating the project reference
- Detail Company Information with Organisation structure.
- ❖ Details of completion of similar type of projects in the last five years under heading:
- a) Brief scope of work b) Value of work in INR c) Contractual Duration d) Actual completion of Project
 - e) Clients name f) Contact details of the Client (Vedanta may approach the client directly for the feedback)
- ❖ Bidder shall provide contract copies of major contracts, service completion certificates, client feedback etc. of similar contracts executed in each of the preceding five years
- Details of current commitments List of all jobs under execution with the value of the Job and percentage completion.
- LTI track record, HSE policy and implementation procedures in line with internationally accepted practices with statistics for last three years, Documents in support of Health & Safety, Environment & Quality [HSEQ] performance.
- ❖ Quality assurance & quality control practices currently in place for the execution of similar work. Copies of ISO 9001, 14001, OHSAS 18001 or any other certification as applicable.
- Company's financial performance documents (Audited Balance sheets and Profit and Loss statements, Auditors Report and Notes to Accounts etc.) for last 2 (two) years. Latest financial statement should not be older than 12 months on the date of submission of response to Expression of interest

Also, note -

- i. Normally standalone financials of the bidding entity only will be considered. However, consolidated financials at the bidding entity level, if available, can also be submitted. Parent company or Affiliate's financials can be submitted and considered, subject to submission of Parent/ Affiliate company guarantee. This should be clearly mentioned in the EOI response.
- ii. Evaluation will be done only on the basis of the published annual reports / audited financials containing Auditor's report, Balance sheet, Profit & Loss a/c and Notes to Accounts.
- iii. In case of unaudited statements (if there are no audit requirements for auditing of financials as per the local law), the financials shall be accompanied by a certificate from a Certified Accountant. Certificate should also mention the fact that there is no requirement of audit of the financials as per the local law.

All qualifications and exceptions brought out in Auditor's report and Notes to Accounts would be factored in while undertaking financial evaluation

Further to this, interested contractors would be invited to submit their response via Smart Source (Cairn's e Sourcing Platform).
