Cairn India Energy Limited, "CEIL" on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation (ONGC) seeks Expression of interest from reputed contractors for the Single Point Mooring (SPM) support vessel at Bhogat, Gujarat, India.

The vessel shall be mobilized to and demobilized from the SPM location at Bhogat. The SPM is located at the following co-ordinates in depth of approximately 30 m.

Co ordinates of SPM: 21 deg 56.0 min N. 069 deg 9.9 min E

The nearest landing facility for the supply of fresh water, fuel, Stores and crew change is at Okha or Porbunder in Gujarat, India

CEIL on behalf of its joint venture partners invites reputed Contractors (Indian and international both) with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in international competitive bidding process ("ICB"). In view of the nature of the scope, only those Companies possessing the requisite and proven record of performance in executing at least Two (2) similar job of value exceeding Indian Rupees One Crore in last 5 years should respond to this notice.

Companies are requested, as a minimum, to submit the following documents and details for Prequalification:

1. Health safety Environment system.
 - a) HSE policy and Manual.
 - b) HSE statistics for major projects executed in last 3 years.

2. Letter of Interest with detailed company information:
 - a) State the name of the parent company.
 - b) State the name/address/phone/e-mail of the company that would execute the contract.
 - c) If a joint venture to be proposed, state the name/address/phone/email of all joint venture partners.
 - d) Organization structure.
 - e) Size of the departments.

3. Company's financial performance documents(Including JV Partner's financial , if proposed) i.e. Audited balance sheets, Profit and Loss Account & cash flow statement for last 3 years & following details separately.
 - a) Company Turnover of Indian Rupees Four Crores in any of the last 3 years based on last 3 audited/Financial statements.
 - b) Company's net worth based on last 3 audited/Financial statements.
 - c) Working capital based on last 3 audited/financial statements.
 - d) State the banker's name, address and Solvency certificate from bank indicating the credibility limit in financial terms.
4. Details of Previous Experience and fleet owned / managed by company.
 - a) List of similar projects successfully executed in last three years in India or abroad with completion certificate and those of currently under execution in offshore sector.
 - b) Details of SPM support services executed for more than Indian Rupees Four Crores.

5. Manpower & Details of vessel & Equipment offered.
 - SPM support vessel shall be steel hull vessel,500 BHP minimum with twin screw and classed with a society which is member of International Association of Classification Societies (IACS) and must be carrying all the statutory certificates as described by her Flag administration, complying with all applicable National, International and local rules and regulations.
 - Details of skilled / trained manpower for carrying out daily / routine preventive maintenance tasks on similar SPM is to be submitted.
6. Discipline and geographical location wise company's fleet strength for providing similar type of services.
7. Details of fleet owned by the company.
8. Quality Systems.
 - a) Copy of International Safety Management certificate (Document of Compliance and Ship management system as applicable.)
 - b) Certification of the company's QA system by an accredited certification body.
 - c) Quality Environment Management System of the company.
 - d) Copy of registration certificate (Labour Law, EPF etc. as applicable)
